#### **ELECTION NEWS**

#### **Absentee Ballot Services**

Spring Lake Park residents who are unable to go to their polling place on Primary or General Election Day may cast an absentee ballot by mail or in-person during the 46 days prior to each election.

Voters who prefer to cast their absentee ballot in-person may do so at the Spring Lake Park City Hall during the hours, 8:00 am to 4:15 pm, Monday through Friday. In-person absentee balloting will also be available at City Hall on the Saturday prior to each election from 9:00 am until 3:00 pm and until 5:00 pm the day before each election.

The absentee balloting period for the Primary Election, August 13, 2024, runs from Friday, June 28 through Monday, August 12, 2024. For the General Election, November 5, 2024, the absentee balloting period runs from Friday, September 20 through Monday, November 4.

Voters who live in Anoka County and wish to vote absentee by mail, can download the absentee ballot application any time at www.anokacounty.us/absentee voting or they may call 763-324-1300 to have an absentee ballot application sent to them.

Voters who live in Ramsey County and wish to vote absentee by mail, can download the absentee ballot application any time at www.co.ramsey.mn.us/elections/absentee or they may call 651-266-2171 to have an absentee ballot application sent to them. # **City Council Filing Opens July 30**

There are two (2) City Council Member seats up for election on the ballot in November. The two (2) Council Member seats will be four-year terms (2025-28).

If you are interested in running for an open seat, you must file an Affidavit of Candidacy. Candidate filing packets will be available July 30 at City Hall from 8:00 am - 4:30 pm.

The filing period will open on Tuesday, July 30 and will close on Tuesday, August 13 at 5:00 pm. The filing fee is \$15 and must be paid with cash or check.

Candidates may withdraw from the ballot by filing and Affidavit of Withdrawal at any time during the filing period and through Thursday, August 15 at 5:00 pm. Filing fees are non-refundable.

- 3. **Minnesota Secretary of State:** Visit the Secretary of State website at <u>www.sos.state.mn.us/elections-voting/</u>. On this site you will find out how to register to vote, where to vote and what is on your ballot.
- 4. Early Voting Locations: Early voting is available in Spring Lake Park, at the City Hall from 8:00 am 4:15 pm.
- 5. **Stay Informed:** Keep yourself updated on any changes to polling places or voting procedures. Visit official websites, follow local news, and subscribe to newsletters or notifications from the city or county elections office.



# 2024 Seal Coat and Pavement Marking Project

As part of the street maintenance, the city completes an annual street maintenance project consisting of crack repair and seal coating. Seal coating includes placing bituminous emulsion and small aggregate on the street surface. The 2024 construction area is for the northwest corner of the city (north of 81<sup>st</sup> Avenue and west of Terrace Road), and pavement markings for the main streets in the entire city. Below is the map of the streets scheduled to be seal coated this summer.

#### **Temporary Traffic Change for Tower Days Festivities**

Tower Days is the annual celebration in Spring Lake Park with festivities at Lakeside Lions Park on Saturday, June 8 and Sunday, June 9. There has been an increase in attendance, which has led to some traffic difficulties in the area. For the 2024 celebration, there will be a temporary traffic flow change for **McKinley St NE**, **79<sup>th</sup> Ave NE**, **and Pleasant View Dr NE**. This area will become one-way traffic to allow for parking on both sides of the street while maintaining traffic flow.

- McKinley St NE will be one-way traffic going southbound from 81<sup>st</sup> Ave NE to 79<sup>th</sup> Ave NE.
- 79<sup>th</sup> Ave NE will be one-way traffic going eastbound from McKinley St NE to Pleasant View Dr NE.
- Pleasant View Dr NE will be one-way traffic going northbound from 79<sup>th</sup> Ave NE to 81<sup>st</sup> Ave NE.

There will be temporary signage along the route during the weekend. There will also be a designated area for handicap and motorcycle parking along 79<sup>th</sup> Ave NE. As always, vehicles are not allowed to park in such a manner as to block a driveway or mailbox. Please see the map for further explanation of the temporary change. If you have questions regarding this temporary change, please call the Police Department or Parks and Recreation.



# **Citizen Survey Launched**

The City is conducting a city services survey as part of its participation in the voluntary Performance Measurement Program through the Minnesota Office of the State Auditor. The purpose of the program is to help residents and local officials determine how effective the city has been in providing core city services and to measure residents' opinions of those services.

The City's performance measures include both objective and subjective indicators of the quality of police services, fire, city streets, water system, sanitary sewer system, overall appearance, and changes in taxable market value and bond rating.

Your opinions on the services we provide are an essential component to evaluating the City's effectiveness. The survey will be open from now until Friday, May 10, 2024. The Performance Measurement Report, which will include the survey results, will be available on the City's website in June.



#### **First-Time Homebuyers** Are you a first-time homebuyer interested in buying a home in Anoka County?

<u>Included cities:</u> Andover, Anoka, Bethel, Blaine, Centerville, Circle Pines, Columbia Heights, Columbus, Coon Rapids, East Bethel, Fridley, Ham Lake, Hilltop, Lexington, Lino Lakes, Linwood Township, Nowthen, Oak Grove, Ramsey, Spring Lake Park and St. Francis.

Minnesota Housing (MHFA) www.mnhousing.gov, the state's housing finance agency, provides funds for various homebuyer and homeowner programs. The County participates in Minnesota Housing's *Start Up* program for first-time homebuyers. The program offers affordable fixed-rate mortgages to qualified buyers; down payment and closing cost loans may also be available. Mobile home purchases don't qualify unless the home is permanently attached to a lot and taxed as real property.

#### Minimum Start Up Requirements for 2024

You may be eligible if you:

- Are a first-time homebuyer or haven't owned a home in the past three years;
- Meet minimum credit score requirements as set by Minnesota Housing;

- Don't exceed gross income limits—Combined household INCOME limits:
  - 1-4 Persons \$99,300\* 5 Person - \$107,300\* 6 Person - \$115,200\* 7+ Persons - \$123,200\*
- Don't exceed purchase price limit Home PURCHASE PRICE limit is: \$515,200\*(11-CountyMetroArea)

 \*Interest rates, income limits and home purchase prices are subject to change during the program year so,
 -Check with your MN Housing approved lender for most current numbers-

- 1. **The first step is contacting an approved lender** (Anoka County doesn't have applications). You must use a lender who is approved by Minnesota Housing. You can find one at *http://www.mnhousing.gov/findalender*.
- 2. You are required to attend a homebuyer education class. Class options include an in-person class *HomeStretch* or *Framework* an on-line course. Class websites at:

  - *Framework:* https://www.hocmn.org/ buyingahome/framework/
- 3. Minnesota Housing offers qualified buyers down payment and closing cost loans up to \$18,000. Anoka County <u>does</u> <u>not fund</u> its own down payment assistance program.
- 4. Minnesota Housing also offers loans for:
  - Repeat buyers and refinancing through its **Step Up** program; and
  - Home improvement through its **Fix-Up Loan** program.

The open book meetings provide a forum for you to meet with assessment staff on an informal basis to review information about your property and to ask questions about the assessment. You do not need to make an appointment to meet with the assessment staff. You can simply show up at the dates/times below to discuss your assessment.

For properties located in Anoka County, open book meetings will be held on Tuesday, May 7 from 1:00 pm to 7:00 pm and on Wednesday, May 8 from 8:00 am to 4:30 pm. Both meetings will be held at the Anoka County Government Center, 2100 3<sup>rd</sup> Avenue in Anoka.

If you are not satisfied with the outcome of the open book meeting, you can appeal your property valuation to the County Board of Appeal and Equalization. To obtain an appeal form for Anoka County residents, please contact 763-324-1175. For Ramsey County residents, please contact 651-266-2131.

As warmer weather approaches, many of us are gearing up for exciting home improvement projects. To ensure a smooth and successful process, it's crucial to be aware of the necessary permits for various undertakings. Whether you're embarking on a new construction or enhancing your existing space, compliance with local regulations is key.

Here's your comprehensive guide to common permit requirements for different home improvement projects:

#### **Common Permit Requirements:**

- Fences *zoning*.
- Driveways *zoning*.
- Swimming pools *building*.
- Accessory buildings (detached garage and sheds) 200 square feet or less zoning.
- Accessory buildings (detached garage and sheds) over 200 square feet *building*.
- Decks *building*.
- Re-roofing *building*.
- Window replacement *building*.
- Siding *building*.
- Basement remodeling or repairs *building*.
- Retaining walls (over four (4) feet in height) *building*.
- Towers, antennas and satellite dishes *building*.

#### **Additional Information:**

- Any structural alterations or repairs also require a building permit.
- Finishing work such as painting, papering, tiling, and carpeting do not require a permit.
- Separate permits are required for the installation of new plumbing and heating equipment.

#### **DIY and Contractor Guidelines:**

- Homeowners may do the work themselves only if they reside in the home where the work is being conducted.
- Residential contractors must carry a State of Minnesota residential contractor's license if required by state law.
- Commercial contractors must be licensed and bonded with the City of Spring Lake Park before submitting
- the permit application and commencing any work.

# **Long Grass**

As the weather begins to warm up, please remember that all lawns must be maintained in an appropriate manner. This includes all noxious weeds, tall grasses defined as anything over nine inches, and other rank growths.



# Managing Grass Clippings and Leaves

Do not blow or rake grass clippings and leaves into the street as this is unsafe for bikes and motorcycles and a violation of our City Code. Leave them on the lawn. Leaves and grass clippings can be used for compost, or you can bag them up and bring them to a yard waste site.

# **Hire Licensed Contractors**

Whether you're embarking on a new construction or enhancing your existing space, hiring a licensed contractor is important.

By hiring a licensed contractor, they have proven their legitimacy and insurance coverage so residents can be assured they are dealing with a reputable and established business.

# Pet Licensing

All dogs must be licensed with the city each year. The pet license schedule runs from April 1<sup>st</sup> – March 31<sup>st</sup> of each year. For pet owners to license their e animals they must show current proof of rabies vaccination. Dogs must be on a leash when outside, with the exception of a fenced in yard. It is the pet owner's responsibility to clean up any



defecation by their pet. All cats must be licensed once within their life time. Pet license applications can be found on page 16 or on our website at www.slpmn.org.

All dogs MUST be on a leash in City Parks.

#### FIRE DEPARTMENT

#### **Safely Dispose Fireworks**

According to the National Fire Protection Association, fireworks started an estimated 19,500 fires in 2018, including

1,900 structure fires, 500 vehicle fires, and 17,100 outside and other fires. These fires caused five deaths, 46 civilian injuries, and \$105 million in direct property damage. Stay safe this season by following these fireworks disposal tips:



- Never discard used fireworks directly into the trash.
- Always soak used fireworks in a bucket of water for at least 24 hours, then place them in the trash.
- Unused and expired fireworks should also be soaked in a bucket of water for 24 hours. Then, double bag them to keep them wet before placing in the trash.

# **Fire Pit Safety Tips**

Recreational fires have become an important part of our outdoor experience. In order to ensure that these types of experiences can continue without creating a safety hazard or nuisance, the recreational fire regulations listed below have been developed. Recreational fires are permitted under the following conditions:

- Only natural firewood cut in short lengths less than two (2) feet may be burned. The fire must be contained in a manufactured freestanding fire pit or ring not exceeding three (3) feet in diameter.
- All fire rings or pits must be located a minimum of 25 feet away from any structures or combustibles, such as houses, garages, sheds, wood piles, and wooden fences.
- The fire must be constantly attended and supervised by an adult until the fire has been completely extinguished.
- A connected garden hose or other means to extinguish the fire must be readily available. The use of flammable or combustible liquid accelerants is not permitted.
- Recreational fires are not permitted on windy days when the smoke may create a nuisance for nearby neighbors.

# **Prevent Smoking Related Fires**

Did you know that careless smoking is the leading cause of fatal fires in Minnesota? Smoking material fires are preventable. Follow these recommendations from the National Fire Protection Association to avoid fires related to smoking materials:

- If you smoke, smoke outside. Most deaths result from fires that started in living rooms, family rooms and dens or in bedrooms.
- Keep cigarettes, lighters, matches, and other smoking materials up high out of the reach of children, in a locked cabinet.
- Use a deep, sturdy ashtray to dispose of smoking materials. Place it away from anything that can burn.
- Do not discard cigarettes in vegetation such as mulch, potted plants or landscaping, peat moss, dried grasses, leaves or other things that could ignite easily.



- Before you throw away butts and ashes, make sure they are out. Dousing in water or sand is the best way to do that.
- Never smoke and never allow anyone to smoke where medical oxygen is used.

#### **Severe Weather Awareness Week**

Minnesota's Severe Weather Awareness Week is April 8 - 12, 2024. The statewide tornado drills are scheduled for Thursday, April 11 at both 1:45pm and 6:45pm. Outdoor warning sirens will sound for a simulated tornado warning. The first drill is intended for institution and businesses. The evening drill is for second shift workers and families. This is the perfect time for families to plan and practice what to do in the event a tornado is approaching.

The MN Department of Natural Resources states Minnesota experiences an average of 29 tornadoes per year. In 2021, there were 64 recorded tornadoes, including 22 on December  $15^{\text{th}}$  alone! The record for total number of recorded tornadoes in Minnesota was in 2010 with 113 touching down across the state! Take the time to learn how to respond when a tornado is approaching – it can save lives.

# **Increased Motorcycle Traffic**

Many of us have seen motorcycles on the road during this winter that isn't really a winter. Motorcycles are unlike any other vehicle on the road, therefore, they require special consideration. While motorcycles are nearly as likely as passenger vehicles to be involved in crashes, motorcyclists are

almost three times more likely to be injured and five times more likely to be killed in a crash. Motorcycles have increased in popularity due to being fun, relatively inexpensive to own and insure, and get excellent gas mileage. Due to this popularity, it



becomes even more important for drivers to share the road. In many car vs. motorcycle crashes, drivers claim they "didn't see" the motorcycle, or didn't see it until it was too late. Motorcycles are smaller, making them harder to see, which requires everyone to take greater care to watch for them on the roads. This means to slow down, keep your eyes on the road, and don't drive distracted.

#### **Juvenile Curfew**

As the weather gets warmer and the days get longer, more time will be spent outside. The City of Spring Lake Park and neighboring communities share and enforce the same curfew hours for all juveniles. Spring Lake Park Ordinance 13.04.050 contains information regarding juveniles under the following ages, and states they may not be in a public place without direct parental or guardian supervision:

#### Under Age 12

- Sunday Thursday: 9:00 PM to 5:00 AM

# **Hydrant Flushing**

City employees will begin flushing the water system the week of April 15. The following dates have been scheduled for flushing:

PROBLEM. IF YOU NEED TO DO LAUNDRY PLEASE DO SO AFTER 4:00 PM.

It is not possible to determine which areas of the City will have an excessive amount of sediment at any particular time during the flushing, as the water pressure and location of the water lines sometimes causes a disturbance many blocks from the point of flushing.

#### Street Sweeping

Street sweeping is expected to begin at the end of April, or the beginning of May, weather permitting. It is very difficult for the driver of the sweeper to see all of the activity around him, so everyone is cautioned to maintain a safe distance



from the street sweeper. Parents, PLEASE INSTRUCT YOUR CHILDREN TO STAY AWAY FROM THE MACHINE WITH THEIR BICYCLES.

# Odd and Even Day Watering

Spring Lake Park has regulations for outside water use. Per Resolution No. 93-17 if your address ends in an odd number,

outdoor watering is allowed only on the odd numbered days of the month. If your address ends in an even number, outdoor watering is allowed only on even days of the month. Exceptions are allowed for new sod, seed or landscaping for the first two weeks after planting.



# **Roadways Spring Load Limits (SLL)**

During the spring, pavement layers are generally in a saturated, weakened state due to partial thawed conditions and trapped water in the road bed. The critical time for SLL is when the pavement first thaws. Load limits began February 26 and will last for 7 to 9 weeks. Load limit permits are required for the City of Spring Lake Park.

#### **Emerald Ash Borer**

Emerald Ash Borer (EAB) is a tree pest that attacks and eventually kills Ash trees. EAB is a small green beetle that, as adults, sparingly eat the leaves of Ash trees. But the real damage to the tree, which ultimately results in the eventual death, is caused by feeding of the EAB larvae underneath the bark of Ash trees. By the time damage is visible in the canopy of an Ash tree, it is usually too late to try to save the tree.

EAB is Native to Eastern Asia. It was identified in Detroit, Michigan and Windsor, Ontario in 2002. Today, it has been confirmed in a total of 36 states, including Minnesota. EAB has been found in several counties on the eastern side of Minnesota.

EAB damage can be identified in several ways. Woodpecker damage is one of the best potential early indicators of EAB. Woodpeckers feed on EAB larvae (which are under the bark), so increased Woodpecker activity can be a sign that there may be EAB larvae (or other insect larvae) feeding underneath the bark. Vertical cracks may also appear on the surface of the tree. The tunneling of the very active EAB larvae can cause splits in the bark which will reveal their distinct S-shaped galleries beneath the bark. Finally, look for small D-shaped exit holes on trees. The body of the adult EAB has a flat back and curved abdomen, leaving the distinct D-shaped exit hole in the bark when it chews its way out of the tree. The adult insect is pretty small, making

these exit holes challenging to see on the rough bark of Ash trees.

The adult EAB flight season is considered to begin May 1 and last through September 30. Within this time, it is critical that Ash wood not be transported to different locations to ensure that the spread of EAB is not accelerated. Like some other pests/ diseases, EAB is easily spread by transporting Ash firewood (from infested trees). So, unless the firewood is Minnesota Department of Agriculture (MDA) certified, do not

transport it across or within Minnesota's borders. If you detect or think you detect EAB, note the location, take a digital photo, and contact the U.S. Department of Agriculture at 1-866-322-4512 or report online at

# **Plastic Recycling Guide**

Plastic, more than any other recyclable material, generates the most questions and confusion from residents. There are so many different types and uses of plastic you need to know some basic principles to make sure you are putting the correct plastics in your curbside bin. This article should help you recycle correctly!

#### **Plastics Recyclable Curbside**



These numbers are located on the bottom, on the neck, and on lids, tub covers and to-go containers. They are used to identify the type of plastic it is. If the container doesn't have a code, throw it away.

#### • Do not include these items (even if they are a 1, 2 or 5):

- Black plastics too dense to be identified by sorting equipment.
- Smaller than your fist Throw away loose caps, condiment cups, and small prescription bottles.
- Opaque #1 PET Fair Life Milk or other colorized, very glossy PET containers are not wanted by manufacturers of clear, #1 PET products.
- No containers larger than three (3) gallons.
- ° Large, bulky items, such as, laundry hampers, children's toys, lawn chairs or big cat litter tubs.

#### • Empty contents, rinse and place cap back on container before recycling

- Rinse out containers before depositing in your recycling cart, especially smoothie or specialty drinks that had whipped cream.
- ° Throw away straws, pumps or spray nozzles.
- <sup>°</sup> Most of the caps on plastic bottles are plastic, simply place the cap back onto your empty, rinsed container. You do not have to find a number on small caps.
- Remove plastic overwrap from container Plastic overwrap is usually a different type of plastic than the container so
  the optical sorter may not detect the correct number. This is found on yogurt cups, beverage bottles and various
  condiment containers.

#### **Prevent Dumping into Streets and Stormdrains**

To help reduce water pollution from stormwater runoff, City ordinances classify anything other than water going into the street or storm drains as illegal - called "Illicit Discharges."

If you see anyone spilling, dumping or disposing of materials into a stormdrain or the street report it immediately. Call the Public Works department from 8:00am - 4:30pm at 763-784-6491. If you think it's a hazardous material emergency, call 9-1-1.

#### **Illicit Discharges**

- Motor oil and grease
- Pesticides, herbicides
- Paint
- Winter de-icers/salt

#### "Organic" materials

- Grass clippings
- Leaves
  - Sand
    - "Pet-friendly" winter de-icers
    - Fertilizer
    - Bare dirt

#### **Keep a Lake-friendly Lawn!**

With Springtime here, it's time to remember that lawn care can pollute our rivers, streams, and lakes.

Pesticides, fertilizers, and grass clippings are all pollutants that can come from lawns. Rain runoff can wash fertilizer or pesticides off lawns and pick up grass clippings left on driveways, sidewalks, or curbs. This polluted rainwater then flows to street storm drains and can run straight into local waterbodies.

Fertilizers and clippings in water can feed algae and cause algal blooms. Algae blooms can smell, be unsightly, and cause fish die-offs.

Lawncare tips for a Lake-friendly lawn:

- Keep your turf three (3) inches tall to promote root growth, reduce weed growth and reduce watering.
- Sweep up any grass clippings on sidewalks and driveways; instead, mulch your clippings as fertilizer.
- Before applying fertilizers, test your soil with the UMN -your soil might be just fine, so save some money.
- Only water if it hasn't rained! Then, water deeply (1-1.5 inches) once a week to enhance root growth.
- Try to manually remove weeds first. Then, if using herbicides, follow the label directions.
- Take old or frozen pesticides to the Anoka County Household Hazardous Waste Facility. For hours and rules, contact the facility at AnokaCounty.us/HHW or at 763-324-3400.

# Please Don't Feed Ducks and Geese!

While it is tempting to feed waterfowl it is unhealthy for them, for us, and our waters!

- Feeding can concentrate ducks and geese into one area, making it easier for • disease to spread among the birds.
- Wild food is much more nutritious. Don't feed bread or junk food.
- Feeding can cause ducks and geese to lose their fear of humans, and become more likely to attack people.
- Overcrowding can also cause water pollution from E. coli bacteria since their waste is concentrated.

If you want to help ducks and geese, provide or support habitat that provides their natural food, nesting, and migratory needs. Learn more from the state Duck action plan: https://www.dnr.state.mn.us/wildlife/waterfowl/index.html
